## Dear Researcher:

The California Table Grape Commission (commission) is pleased to announce its request for Letters of Intent to submit a proposal for its 2026-27 Health Research Grant program. Letters of Intent are sought for \$50,000 grants toward research on any relevant health issue in which grape consumption may have a beneficial impact. Of particular interest is the impact of grapes on brain, eye, GI, immune, and skin health, however applicants are welcome to propose grape research in other areas as well.

The major goal of this program is to fund **human** pilot studies that examine the potential health benefits of grape consumption.

To facilitate grape research, the commission developed a freeze-dried table grape powder made from fresh California table grapes that is to be used for work funded by this grant program. It is not an extract. The powder is a composite of seeded and seedless red, green, and black California grapes. As with fresh grapes, the powder is known to contain simple phenolics, resveratrol, flavans (including catechins), flavonols (including quercetin), and anthocyanins.

Following the review of submitted Letters of Intent, finalists will be invited to submit a complete proposal to the commission. Please note, that the Letter of Intent must be submitted electronically, in a single PDF file.

Deadline for submission of a Letter of Intent is Tuesday, October 28, 2025 at 5:00 p.m. Pacific Standard Time (PST). For the Letter of Intent Guidelines please visit <a href="https://www.grapesfromcalifornia.com/HRG26">https://www.grapesfromcalifornia.com/HRG26</a>.
